## 1974 Program of Field Trips

Only series subscribers to the Speakers Program may purchase tickets for the Field Trips, which are conducted on a Tuesday or a Wednesday schedule the week following each discussion. A tour ticket is valid only on the date for which the ticket is issued, and must be presented for admission. There are no refunds on field trip tickets, and no replacement of lost tickets can be made. The price of each tour is \$9.00. Luncheon (gratuity included) is provided on all tours. Tours depart from and return to the Clinton

Street (west) Entrance to the Chicago & North Western Station (except Tour Five, see below). Tours operate on closely coordinated schedules, and the departure of buses cannot be delayed for late-comers. Comfortable shoes are recommended. Since program arrangements must be made many months in advance, scheduled events may sometimes be subject to change. Please read carefully the instructions on How to Order Tickets.

#### Tour One Tuesday, Sept. 17 Wednesday, Sept. 18

Depart promptly 9:00 a.m. for Bally Manufacturing Corp., 2640 W. Belmont, to tour the slot machine assembly line and try out the amusements in a demonstration playroom. Then to the Police Academy and its collection of gambling games nabbed in vice raids. At Hawthorne Race Track we enter the world of Harry the Horse and take a gander through the stable area, including the tack rooms, dining hall for track personnel, horse testing facilities and maintenance

equipment station. At the clubhouse we learn from the tote machines the inside dope on how the computer handles the bets. Lunchtime fodder in the Terrace Room, a classy private club overlooking the track, where we meet the track owner and a savvy jockey. Special escorts available for those wishing to visit the paddock area to confer with the horses. Post time is 2 o'clock, and they're off! Tour ends at approximately 3:30 p.m.

#### Tour Two Tuesday, Oct. 1 • Wednesday, Oct. 2

Depart 8:45 for The Juvenile Protective Association's Bowen Center, 2761 N. Seminary. Welcome by G. Lewis Penner, JPA Director, followed by a brief film on the Center and tour. Proceed to the Special Service Unit, Illinois Dept. of Corrections, where Daniel Simons will explain the parole program of which he is in charge, followed by Harold Thomas, Commander of the Youth Division of the Chicago Police Dept.

Lunch in the Illinois Room 322 at Chicago Circle Campus. At the auditorium of the Juvenile Courts, we will be greeted by Judge White and will hear from Seymour Adler, Director of Court Services, and from James Jordan, Director of the Detention Center, as well as members of their staff. The remainder of the afternoon will be spent visiting the Courts. Tour ends approximately 3:30 p.m.

Tour Three Tuesday, Oct. 15 Wednesday, Oct. 16

Depart 8:45 in two groups: *Group 1* visits the Dysfunctioning Child Center, Michael Reese Hospital, where children with multiple handicaps are diagnosed and treated. Ms. Syril Shaffer, Asst. Prog. Dir., will give a presentation and an audio-visual tape will demonstrate the Center's special approach to teaching the psychotic, non-verbal child. *Group II* visits Pritzker Children's Hospital & Center, 800 E. 55th St. Preceding a tour of this psychiatric hospital, which includes a special Board of Education school, Dr. Pieter de Vryer, Director, will hold a staffing of a particular child, with participating staff from a variety of

disciplines who are involved with the child. Both groups lunch at Sauer's and proceed to the Searle Bldg, for Communicative Disorders at Northwestern, Dr. Daniel Rutherford, Dept. Chmn., will present an orientation to the four programs offered. Their work will be observed in rooms with one-way mirrors. Sound demonstrations will be held in the laboratory's anechoic (echoless) and reverberation chambers. Return by approximately 3:30. (NOTE: Heelless shoes such as loafers should be brought to wear into the anechoic chamber at N.U.)

Tour Four Tuesday, Oct. 29 • Wednesday, Oct. 30

Depart 8:45 sharp for Amoco Research Center, Naperville, Illinois. (NOTE: You may drive to the Center and meet the tour at 9:45. Exit from East-West Tollway at Naperville Road; go north to first stoplight (Warrenville Road), turn west and proceed to Center, stopping at the guard house for parking directions.) The tour will include three areas of research and de-

velopment in which Standard Oil (Indiana) and one of its subsiduaries, Amoco, Chemicals Corp., are involved: (1) research which led to the formation of Amoco Foods Co., (2) development of additives used in lubricating and fuel oils, (3) work on plastics developed for a myriad of consumer products. Lunch at Amoco's lakeside dining facilities. Return by 3:30.

Tour Five Tuesday, Nov. 12 . Wednesday, Nov. 13

Tour begins promptly at 9:00 from lobby of the main Wacker Drive entrance to the Sears Bldg., ascending to the top for viewing and to see the Sears Board Room, then to the auditorium for a slide presentation about the building, followed by a visit to the offices of Northwest Industries. Proceed by bus to the Standard Oil Bldg., for a talk with slides on its concept and construction, visits to the offices of Kirkland & Ellis and to the executive offices of Standard Oil, finishing

with a walk-through of a typical floor with emphasis on the huge art collection. The afternoon will be spent at the Johnson Publishing Co. Bldg., with lunch at 1:00 p.m. in the executive dining room, followed by a special tour that will include Mr. and Mrs. Johnson's private offices and a film about the collection of Black and African art. Buses return both to Sears and to the North Western Station, at approximately 3:15–3:30 p.m.

The tours are offered in four Field Trip Series: Series A (omits Tour 1); Series B (Omits Tour 2); Series C (Omits Tour 3); Series D (Omits Tour 5). It is important to show your preference with alternative choices: A subscriber who lists first, second and third choices will have his order filled strictly in accordance with his preference, to the extent that tickets remain available.
